<u>SPR-6-19-1</u>: Request by 2001 Properties LLC., for a Site Plan Review of a proposed addition onto their existing building to be compliant with Zoning Ordinance Section 22.02 4. Site Plan Review. The property is located at 300 Wright Industrial Parkway, Potterville, Michigan.

**Staff Report:** Ms. Hatt read the staff report into record.

**Commissioner Swanson** asked about the landscape plan. He stated the number and species of trees is identified on the landscape plan. Ms. Hatt stated that is correct, but she does not believe the proposed landscape plan meets the requirements of Zoning Ordinance Section 4.04 Greenbelt Regulations. She stated with the Planning Commission's approval she is able to work with the applicant on an approved landscape plan prior to issuance of a Zoning Referral.

**Applicant Statement:** Mr. Greg Dobie stated he will be compliant with anything the Planning Commission requires of him. He stated they would like to move some of their existing trees; there is an existing berm on the back of the property, planting more trees could help block the building. Mr. Dobie stated he wants to be a good neighbor. He stated his business supports local activities. He stated the machinery for the operation of the business is located on the other end of the building.

**Commissioner Bruggink** stated it is exciting to have business expand their operations. Mr. Dobie stated they have a lot of local employees, but they need more. He stated they struggle finding new employees. He stated he works with three employment agencies to find new employees. His company officer tuition incentives, profit sharing, and 401K. Mr. Dobie stated his employees own the company.

**Commissioner Swanson** asked Mr. Dobie about the driveway. Mr. Dobie stated the driveway will meet commercial driveway standards.
