**ORDINANCE TO REPEAL THE CITY OF POTTERVILLE
CODE OF ETHICS AND ADOPTING NEW CHAPTER 3, SECTION 5-4**

THE CITY OF POTTERVILLE ORDAINS:

Section 1.

The City hereby repeals Ordinance No. 231, "Ordinance to Adopt a Code of Ethics for the City of Potterville," codified at Chapter 3 of the City Code of Ordinances, Secs. 1-1 through 5-3, in its entirety.

Section 2.

The City hereby adopts new Section 5-4 of Chapter 3, which shall read as follows:

Employees and elected officials of the City of Potterville shall comply with all obligations imposed on them by the Political Activities of Public Employees Act, Act 169 of 1976, MCL 15.401 *et seq*; the Contracts of Public Servants with Public Entities Act, Act 317 of 1968, MCL 15.321 *et seq*; and the Standards of Conduct for Public Officers and Employees Act, Act 196 of 1973, MCL 15.341 *et seq*.


Section 3.

All ordinances inconsistent with this Ordinance are repealed to the extent necessary to give this Ordinance full force and effect.


Section 4.

Section 1.

WHEREAS, the City of Potterville ("City") has adopted Ordinance No. 231, Ordinance to Adopt a Code of Ethics for the City of Potterville, which is codified at Chapter 3 of the City Code of Ordinances, Secs. 1-1 through 5-3 ("Code of Ethics"); and

WHEREAS, the City has concluded that the Code of Ethics has failed to fulfill its intended purposes and has resulted in unnecessary costs and expenses; and

WHEREAS, the City introduced a proposed ordinance to repeal the Code of Ethics and held a duly noticed public hearing concerning the proposed ordinance on November 20, 2014; and

WHEREAS, the City concludes that adopting the ordinance to repeal the Code of Ethics is in the best interest of the public health, safety, and welfare.

NOW, THEREFORE, the City Council of the City of Potterville resolves as follows:

1. Ordinance No. 2014-~~239~~ Ordinance to Repeal the City of Potterville Code of Ethics (the "Ordinance," attached as Exhibit A) is hereby adopted.
2. The Ordinance shall be filed with the City Clerk.

3. The City Clerk shall publish the Ordinance and notice of its adoption in a newspaper of general circulation in the City.

4. Any and all resolutions that are in conflict with this Resolution are hereby repealed upon the effective date of the Ordinance but only to the extent necessary to give this Resolution full force and effect.
